TRADEMARK AND SERVICE MARK ASSIGNMENT

THIS TRADEMARK AND SERVICE MARK ASSIGNMENT, dated as of June 4, 2001, is from AT&T CORP., a New York Corporation, 32 Avenue of the Americas, New York, New York 10013-2412 ("AT&T") to AT&T WIRELESS SERVICES, INC., a Delaware corporation, 16331 NE 72nd Way, Redmond, WA 98052 ("AWS"). Capitalized terms used herein and not otherwise defined shall have the respective meanings assigned to them in Article 1 hereof or as assigned to them in the Separation and Distribution Agreement (as defined below).

WHEREAS, the Board of Directors of AT&T has determined that it is in the best interests of AT&T and its shareholders to separate AT&T's existing business so that AWS will operate as an independent business; and

WHEREAS, in order to effectuate the foregoing, AT&T and AWS have entered into a Separation and Distribution Agreement, which provides, among other things, subject to the terms and conditions thereof, for the separation of the AWS Assets and the AWS Liabilities, the Distribution and the execution and delivery of certain other agreements in order to facilitate and provide for the foregoing; and

WHEREAS, this Trademark and Service Mark Assignment transfers to AWS certain trademark and service mark assets and related goodwill that have been developed by AWS; and

NOW, THEREFORE, the parties, intending to be legally bound, agree as follows:

**ARTICLE I
DEFINITION**

ASSIGNED MARKS means those trademarks and service marks and trade mark and service mark applications and registrations set forth on Schedule A to this Agreement.

**ARTICLE II
ASSIGNMENT**

2.1 AT&T hereby irrevocably transfers and assigns to AWS all of its rights, title and interest in and to the Assigned Marks in the United States and throughout the world, any common law rights relating to the Assigned Marks, the goodwill of the business represented by the Assigned Marks, and the right to sue for past infringement of the Assigned Marks.

2.2 AT&T will neither use nor attempt to register any Assigned Marks or any confusingly similar mark for so long as said Assigned Mark has not been abandoned by AWS.

2.3 AT&T will execute any and all papers reasonably requested by AWS to effect transfer and recordal of the Assigned Marks to AWS.

2.4 AT&T makes no representations or warranties with respect to AWS's ability to use the Assigned Marks or with respect to the validity, enforceability or registrability of the Assigned Marks.

2.5 The side letter agreement of even date herewith between AWS and AT&T is incorporated into this Agreement as Schedule B, and becomes a part of this Agreement.
