ASSIGNMENT OF TRADEMARKS

This Assignment of Trademarks is made and entered into as of this 21 day of OCTOBER, 2003 (the "Effective Date"), by and between Firevine, LLC, a Delaware limited liability company ("Firevine"); and Navigant International, Inc., a Delaware corporation ("Navigant") (collectively referred to as the "Parties").

WHEREAS, Navigant wishes to acquire all rights, title and interest in and to the Trademarks; and

NOW, THEREFORE, in consideration of the above Recitals, which are incorporated herein by this reference, and for other goods and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

1. Firevine hereby assigns to Navigant all of its rights, title and interest in and to the Trademarks.
2. This Assignment of Trademarks may be executed simultaneously in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.


