INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS INTELLECTUAL PROPERTY SECURITY AGREEMENT is made and entered into as of February 14, 2002 (this "IP Security Agreement"), by and between WORTH MEDIA LLC, a Delaware limited liability company formerly known as CP Acquisition LLC and Capital Publishing LLC (the "Debtor"), and GSCP II HOLDINGS (CP), LLC, a Delaware limited liability company (the "Secured Party").

RECITALS

A. The Debtor has previously issued to the Secured Party a series of demand notes in the aggregate principal amount of Fourteen Million Eight Hundred Seventy-Five Thousand Dollars (\$14,875,000) (collectively, the "Demand Notes").

B. In order to induce the Secured Party to enter into the Amended, Restated and Consolidated Promissory Note, issued by the Debtor to the Secured Party and dated as of the date hereof (the "Note"), and the other transactions contemplated by that certain Letter Agreement dated as of the date hereof (the "Letter Agreement") by and among the Debtor, the Secured Party, Greenwich Street Capital Partners, Inc. and Mr. W. Randall Jones, and to ensure that the loan made pursuant to the Note (the "Loan") will be secured as provided herein, the Debtor has agreed to enter into this Agreement pursuant to which the Debtor grants to the Secured Party, for the benefit of the same, a first priority security interest in all of the personal property of the Debtor as security for the Secured Obligations (as defined herein).

C. Under the terms of the Security Agreement, the Debtor has granted a security interest in certain intellectual property of Debtor to the Secured Party and the parties hereto have agreed to execute this IP Security Agreement for recording with the U.S. Patent and Trademark Office, the United States Copyright Office, and other governmental entities.

D. Capitalized terms used, but not defined, herein have the meanings ascribed thereto in the Note.

AGREEMENTS

In consideration of the foregoing Recitals, and of the agreements made herein, and of the Loan by the Secured Party to the Debtor and the other transactions contemplated by the Letter Agreement, the Debtor and the Secured Party agree as follows:

1. GRANT OF SECURITY INTEREST.

1.1 Collateral. The Debtor hereby grants to the Secured Party a security interest in and to all of the Debtor's right, title and interest in and to the following (the "IP Collateral"):

(a) all patents and patent applications, including, without limitation, those set forth in Schedule A hereto including inventions and improvements described and

claimed, therein together with the reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof (collectively, the "Patents");

(b) all trade names, trademarks and service marks, logos, trademark and service mark registrations, and applications for trademark and service mark registrations, including, without limitation, those set forth in Schedule B hereto including all renewals of trademark and service mark registrations thereof (collectively, the "Trademarks");

(c) all copyrights, copyright registrations and applications for copyright registrations, including, without limitation, those set forth in Schedule C hereto including all renewals and extensions thereof (collectively, the "Copyrights");

(d) any and all claims and causes of action for damages for past, present and future infringement, misappropriation or breach with respect to the Patents, Trademarks and Copyrights, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages for such infringement, misappropriation or breach; and

(e) any and all proceeds of the foregoing.

1.2 Obligations Secured. The security interests of the Secured Party under this Agreement secure (a) the payment and performance by the Debtor of a portion of the indebtedness evidenced by the Note equal to Two Million Dollars (\$2,000,000) in principal amount, together with accrued and unpaid interest on such \$2,000,000 from and after the date hereof (the "Secured Amount"); (b) all payments made or expenses incurred by the Secured Party under this Agreement and the Note, including, without limitation, reasonable attorneys' fees and legal expenses, in the exercise, preservation or enforcement of any of the rights, powers or remedies of the Secured Party, or in the enforcement of the obligations of the Debtor, hereunder or thereunder; and (c) any renewals, continuations or extensions of any of the foregoing (all of which are referred to herein as the "Secured Obligations").

2. RECORDATION. The Debtor authorizes and requests that the Register of Copyrights, the Commissioner of Patents and Trademarks and any other applicable government officer record this IP Security Agreement.

3. COUNTERPARTS. This IP Security Agreement may be executed in any number of counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.

4. GRANTS, RIGHTS AND REMEDIES. This IP Security Agreement has been entered into in conjunction with the provisions of the Security Agreement. The Debtor does hereby acknowledge and confirm that the rights and remedies of the Secured Party with respect to the Collateral and the security interest granted herein are without prejudice to, and are in addition to those set forth in the Security Agreement, all the terms and provisions of which are incorporated herein by reference as if fully set forth herein. In the event that any provisions of this IP Security Agreement are in conflict with the Security Agreement, the provisions of the Security Agreement shall govern.

5. GOVERNING LAW. THIS IP SECURITY AGREEMENT AND THE DUTIES, RIGHTS, POWERS AND REMEDIES OF THE PARTIES HERETO SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK, WITHOUT REGARD TO THE CONFLICTS OF LAWS PROVISIONS THEREOF, EXCEPT TO THE EXTENT THAT THE LOCAL LAW OF ANY JURISDICTION WHERE ANY COLLATERAL IS LOCATED GOVERNS THE PERFECTION OR ENFORCEMENT OF THE SECURITY INTERESTS AND LIENS GRANTED PURSUANT TO THIS AGREEMENT.


