**DOES HEREBY CERTIFY:**

**FIRST:** That the Board of Directors of said corporation, by the unanimous written consent of its members, filed with the minutes of the Board, adopted a resolution proposing and declaring advisable the following amendment to the Certificate of Incorporation of said corporation:

**RESOLVED,** that the Certificate of Incorporation of Norton Performance Plastics Corporation be amended by changing the First Article thereof so that, as amended, said Article shall be and read as follows:

**"FIRST: The name of the corporation is Saint-Gobain Performance Plastics Corporation."**
