**ARTICLES OF AMENDMENT
TO THE RESTATED ARTICLES OF INCORPORATION OF
TRM COPY CENTERS CORPORATION**

Pursuant to ORS 60.447, TRM Copy Centers Corporation (the "Corporation") has adopted an amendment to its Restated Articles of Incorporation.

1. The name of the Corporation is TRM Copy Centers Corporation.
2. Article I of the Restated Articles of Incorporation is hereby amended to read in its entirety as follows:

"ARTICLE I

The name of this Corporation is TRM Corporation."

3. The amendment was adopted on June 24, 1998.
4. The amendment was duly adopted by the board of directors, and shareholder action was required to adopt the amendment. A total of 7,056,811 shares of voting Common Stock were outstanding and entitled to vote on the amendment.
5. A total of 5,927,184 shares of voting Common Stock were voted in favor of the amendment, 980 shares of voting Common Stock were voted against the amendment, and 3,300 shares of voting Common Stock abstained.


