TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, as of March 8, 2001, (hereinafter referred to as the "Effective Date"), EMIL SHAHEEN, a citizen of the United States of America, residing at 6184 East Baja Drive, Anaheim Hills, CA 92807, (hereinafter referred to as the "Assignor") was the owner of all right, title and interest in and to certain trademarks and applications for trademark registration, and the good will associated therewith; and

WHEREAS, effective as of the Effective Date, the said Assignor desires to assign to CALIFORNIA SLINGS AND TIE DOWNS CORP., dba, THE ORIGINAL BUNGEE COMPANY, a California corporation, with offices at 25100 Normandie Avenue, Unit D, Harbor City, CA 90710 (hereinafter referred to as the "Assignee"), the trademarks, good will, and applications for trademark registration which are identified by the following Serial Numbers assigned to the Trademark Applications by the U.S. Patent and Trademark Office: Serial Nos.: 75/891412, 75/891413, 75/928345, 75/928572, and 75/928573 (all hereafter, the "Trademarks");

NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:

Be it known that for good and valuable consideration the receipt of which is hereby acknowledged, Assignor does, as of the Effective Date, assign, transfer, and deliver all of its right, title and interest in and to the Trademarks, together with that part of the goodwill of the business of The Original Bungee Company connected with the use of and symbolized by said Trademarks and obtained by Assignor, to Assignee.

Said Assignor hereby agrees, without further consideration, to sign all lawful papers and to perform all other lawful acts which the Assignee may request, to make this Assignment fully effective, including, without limitation, prompt execution of all other documents necessary to effect the intent of this Assignment.

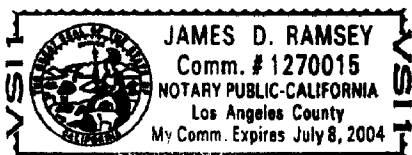


