### RELEASE AND REASSIGNMENT OF INTELLECTUAL PROPERTY


Reference is hereby made to that certain Trademark Security Agreement, dated as of April 30, 1996 (the "Agreement") among Empire Kosher Poultry, Inc., a Delaware corporation ("Borrower"), each subsidiary of Borrower party thereto, and CoreStates Bank, N.A., as agent (the "Original Agent"), on behalf of itself and other Lenders (as defined in the Agreement), which was recorded in the United States Patent and Trademark Office on May 10, 1996 at Reel 1465 Frame 0092 and pursuant to which the Borrower assigned and granted to the Original Agent, on behalf of itself and the Lenders, a security interest in and to all of Borrower's rights, title and interests in and to the collateral listed on Schedule A to the Agreement (the "Collateral"), including without limitation the trademarks, trademark registrations and trademark applications specifically listed on Exhibit A attached hereto and the registrations thereof (the "Trademarks"), together with all of the goodwill of Borrower associated therewith and represented thereby;

WHEREAS, capitalized terms used herein and not defined herein are used as defined in the Agreement; and

WHEREAS, Wachovia Bank, N.A. (the "Agent"), successor by merger to the Original Agent, wishes to release, retransfer and reassign to Borrower, without representation or warranty, all of the Agent's rights, title and interests, on behalf of itself and the Lenders, in and to the Collateral, including without limitation the Trademarks, and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent, on behalf of itself and the Lenders, hereby releases, transfers and assigns to Borrower, without representation or warranty, all of the rights, title and interests of the Agent, on behalf of itself and the Lenders, in and to the Collateral, including without limitation the Trademarks, and the goodwill associated therewith. The Agent hereby authorizes Borrower to take any and all actions in connection with the Trademarks in Borrower's own name and at Borrower's own expense. After the date hereof, the Agent will execute and deliver to Borrower such documents and will take such other actions as Borrower may reasonably request to accomplish the release, transfer and assignment set forth herein.

IN WITNESS WHEREOF, the Agent has executed this Release and Reassignment of Intellectual Property as of this 11<sup>th</sup> day of August, 2003.
