UCC TRANSFER STATEMENT

By this Transfer Statement, pursuant to Uniform Commercial Code §9619, Comerica Bank - California, successor-in-interest to Imperial Bank ("Secured Party"), represents as follows:

1. Default of Obligation. Dental/Medical Diagnostic Systems, Inc. ("Debtor") defaulted in connection with a Fifth Amended and Restated Forebearance Agreement, relating to a Credit Agreement dated January 4, 1999, and other attendant documents and instruments related thereto (the "Obligation"). The Obligation was secured by, among other things, the Debtor's accounts, inventory, equipment, chattel paper, documents, instruments, money, deposit accounts, investment property and general intangibles (collectively the "Collateral").
2. Exercise of Postdefault Remedies. Secured Party exercised its postdefault remedies with respect to the Collateral by, among other things, conducting a public sale pursuant to the Uniform Commercial Code of the Collateral on June 11, 2001.
3. Acquisition of Debtor's Rights. By reason of the exercise of its postdefault remedies, Secured Party ("Transferee") acquired the rights of the Debtor in the Collateral, including described as: (1) the WAVELIGHT trademark; (2) the WAVELIGHT US Registration No. 2,332,459; (3) the "goodwill" symbolized by the WAVELIGHT trademark; and, (4) the wave-light.com domain name.
