THIS ASSIGNMENT, entered into by the parties hereto, is effective as of the date of signing below.





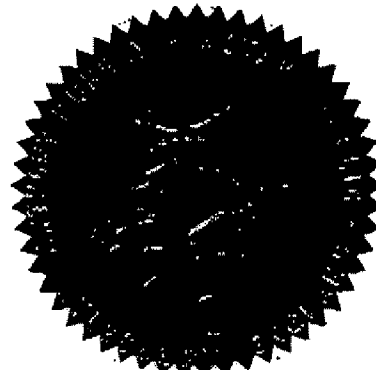
