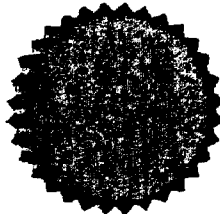

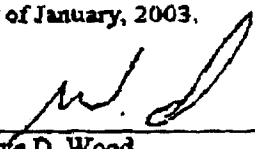
1. He is the Chief Executive Officer and President of MadeToOrder.com, Inc., a Delaware corporation (the "Corporation");
