

NOW THEREFORE, for sums paid to ASSIGNOR by ASSIGNEE pursuant to the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to Section 2.1 of the Purchase Agreement, ASSIGNOR does hereby sell, convey, transfer and assign to ASSIGNEE all right, title and interest of ASSIGNOR in and to the Patents and in and to any reissue, extension, division or continuation of any Letters Patent that may be granted upon said Patents or underlying applications, free and clear of all Encumbrances, excepting only Assumed Liabilities and Permitted Encumbrances.

For said consideration ASSIGNOR hereby agrees, upon the request of said ASSIGNEE, to execute any and all divisional, continuation and renewal applications for said Patents, and any necessary oath or supplemental oath or affidavit relating thereto, and any application for the reissue or extension of any Letters Patent that may be granted on said application that said ASSIGNEE may deem necessary or expedient, and for said considerations ASSIGNOR further agrees upon the request of said ASSIGNEE, in the event of said application or any division thereof, or Letters Patent issued thereon, or any reissue or application for the reissue thereof, becoming involved in interference, to cooperate with said ASSIGNEE, in the matters of preparing and executing the preliminary statement and giving and producing evidence in support thereof, and ASSIGNOR hereby agrees to perform, upon said request, any and all affirmative acts to obtain said Letters Patent and vest all rights therein hereby conveyed in the said ASSIGNEE as fully and entirely as the same would have been held and enjoyed by ASSIGNOR if this assignment and sale had not been made.
