successors and assigns as fully and entirely as same would have been held and enjoyed by Assignor had this assignment, transfer and conveyance not been made.



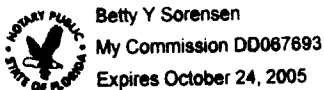
