**QUITCLAIM ASSIGNMENT
OF FEDERAL TRADEMARK REGISTRATION**

D'ASCOLI REVOCABLE LIVING TRUST DATED MAY 24, 1996, whose mailing address is 66-590 Kamehameha Highway, Haleiwa, Hawaii 96712 (the "Assignee"), is desirous of acquiring all of the Assignor's right, title and interest in and to the Mark and the Registration, together with the goodwill of the business associated with and symbolized by the Mark;

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby remise, release and forever quitclaim unto the Assignee, the Assignee's successors in trust and assigns, all of the Assignor's right, title and interest in and to the Mark, together with the goodwill of the business associated with and symbolized by the Mark, and the Registration, and the right to sue for past infringement, if any there may be.

The Assignor, for itself and its successors, hereby covenants with the Assignee, the Assignee's successors in trust and assigns, that to the best of the knowledge of the Assignor, no cancellation actions have been filed against the Registration and no claims or demands for damages relating to goods previously sold under the Mark have been asserted.
