This Agreement is made on 1 January 2003

Between:

- (1) the firm practising as **PricewaterhouseCoopers, United Kingdom Firm** whose principal place of business is 1 Embankment Place, London WC2N 6RH ("**PricewaterhouseCoopers**"); and
- (2) **PricewaterhouseCoopers LLP**, a limited liability partnership (registered number OC303525), whose registered office is at 1 Embankment Place, London WC2N 6RH ("**LLP**")

Whereas:

- (A) **PricewaterhouseCoopers** owns the Trade Marks.
- (B) By a deed of transfer dated 1 January 2003 ("**Deed of Transfer**"), **PricewaterhouseCoopers** agreed to transfer the Trade Marks to **LLP**.
- (C) In accordance with completion under the Deed of Transfer, **PricewaterhouseCoopers** assigns the Trade Marks to **LLP** on the following terms.

The Parties agree and declare as follows:

1 Interpretation

In this Agreement:

"**Effective Date**" means the date of this Agreement;

"**Partners**" means the partners in **PricewaterhouseCoopers** from time to time who are entitled to a share of the profits of **PricewaterhouseCoopers**; and

"**Trade Marks**" means the registered trade marks and trade mark applications listed in the Schedule to this Agreement together with the goodwill of the business symbolised by these trade marks and trade mark applications

2 Assignment

PricewaterhouseCoopers assigns and transfers to **LLP** with effect from the **Effective Date** all its right, title and interest in and to the Trade Marks including, without limitation, all rights of action in respect of the Trade Marks, the right to seek and recover damages and seek other remedies for all past infringement of the Trade Marks and, in the case of any applications for registration of Trade Marks, the benefit of the application with the intent that any registration granted will be the property of **LLP**. **PricewaterhouseCoopers** and **LLP** confirm that **LLP** is a successor to the business of **PricewaterhouseCoopers**, or portion thereof, to which the Trade Marks pertain and that the said business is ongoing and existing.

3 Consideration

Consideration for the assignment in Clause 2 above is £10, receipt of which is hereby acknowledged by **PricewaterhouseCoopers**.

4 Governing Law and Jurisdiction

This Agreement shall be governed by and construed in accordance with English law and the parties agree that the courts of England are to have non-exclusive jurisdiction to settle any disputes which may arise out of or in connection with this Agreement.
