Assignor further authorizes the Commissioner of Patents and Trademarks of the United States and any official of any country or countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Marks and title thereto as the property of the Assignee, its successors and legal representatives and assigns in accordance with the terms of this instrument.

Assignor agrees to execute and deliver further papers and to do such other acts as may be reasonably necessary and proper to vest full title in and to the Marks and the appurtenant goodwill in Assignee.


