## TRADEMARK SECURITY AGREEMENT SUPPLEMENT

**WHEREAS**, DTN Market Access, LLC a Delaware limited liability company (herein referred to as the "Grantor"), having an address at 9110 W. Dodge Road, Suite 200, Omaha, Nebraska, 68114, (1) has adopted, used and is using, or (2) has intended to use and filed an application indicating that intention, but has not yet filed an allegation of use under Section 1(c) or 1(d) of the Trademark Act, or (3) has filed an application based on an intention to use and has since used and has filed an allegation of use under Section 1(c) or 1(d) of the Trademark Act, the trademarks, trade names, trade styles and service marks listed on the annexed Schedule 1-A, which trademarks, trade names, trade styles and service marks are registered in the United States Patent and Trademark Office (the "Trademarks"); and

**WHEREAS**, Data Transmission Network Corporation, a Delaware corporation (the "Borrower"), DTN, LLC, a Delaware limited liability company ("DTN"), certain of the Borrower's and DTN's subsidiaries party thereto, each of the financial institutions from time to time party thereto (the "Junior Lenders") and Wachovia Bank, National Association, as administrative agent and collateral agent for the Junior Lenders have entered into a Credit and Guaranty Agreement (as amended, supplemented, restated or otherwise modified from time to time, the "Junior Credit Agreement") dated as of October 31, 2003.

**WHEREAS**, the Grantor has entered into a Security and Pledge Agreement dated as of October 31, 2003 among the Borrower, DTN, each subsidiary of the Borrower or DTN party thereto and Wachovia Bank, National Association, as collateral agent (in such capacity, the "Junior Collateral Agent") for the Junior Secured Parties (as defined in the Junior Security Agreement). (as amended, supplemented, restated or otherwise modified from time to time, the "Junior Security Agreement") in favor of the Junior Collateral Agent; and

**WHEREAS**, pursuant to the Junior Security Agreement, the Grantor has granted to the Junior Collateral Agent a security interest in all right, title and interest of the Grantor in and to the Trademarks, together with all prints and labels on which said Trademarks have appeared or appear, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, and the goodwill of the business symbolized by the Trademarks and the applications, registrations and recordings in the United States Patent and Trademark Office or in any similar office or agency of the United States of America, any State thereof, or any other country or any political subdivision thereof, all whether now or hereafter owned or licensable by Grantor, and all reissues, extensions or renewals thereof, all Trademark Licenses and all proceeds thereof, including any claims by the Grantor against third parties for infringement thereof (the "Collateral"), to secure the payment, performance and observance of the Obligations (as defined in the Junior Security Agreement);

**NOW, THEREFORE**, for good and valuable consideration, receipt of which is hereby acknowledged, Grantor does hereby further confirm, and put on the public record, its grant to Junior Collateral Agent a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Junior Collateral Agent with respect to the grant of, security interest in and mortgage on the Collateral made hereby are more fully set forth in the Junior Security Agreement; the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


