2. Article I of the Articles of Incorporation is amended to read as follows:


"The name of the corporation is Medivision, Inc."

4. The foregoing Amendment has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The vote was unanimous.


