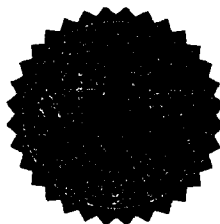

**RESOLUTIONS**  
**OF THE BOARD OF DIRECTORS OF**  
**IREADY CORPORATION, A DELAWARE CORPORATION,**  
**ADOPTED JANUARY 15, 2003**

**Merger of iReady Corporation, a California corporation ("iReady California"), into iReady Corporation, a Delaware corporation ("iReady Delaware")**

**WHEREAS, iReady Delaware lawfully owns all of the outstanding stock of iReady California;**

**WHEREAS, iReady Delaware desires to merge iReady California with and into iReady Delaware, and for iReady Delaware to assume all of the obligations, properties, rights, privileges and franchises of iReady California;**

**WHEREAS, Section 253 of the General Corporation Law of Delaware permits the short form merger of a wholly owned California subsidiary corporation with and into its Delaware parent corporation upon the adoption of a resolution to so merge by the board of directors of such parent corporation and the execution, acknowledgement and filing of a certificate of ownership and merger ("Certificate") with the Secretary of State of the State of Delaware;**

**WHEREAS, Section 1110 of the Corporations Code of California permits the short form merger of a wholly owned California subsidiary corporation with and into its Delaware parent corporation upon the filing of the Certificate, which has been certified by the Secretary of State of the State of Delaware, with the Secretary of State of the State of California;**

**NOW, THEREFORE, BE IT RESOLVED, that iReady California merge into iReady Delaware and iReady Delaware assumes all of the obligations, properties, rights, privileges and franchises of iReady California; and**

**FURTHER RESOLVED, that the officers of iReady Delaware be and they hereby are authorized and directed to do all acts and things whatsoever within or without the state of Delaware that may be in any way necessary or proper to effect such merger.**
