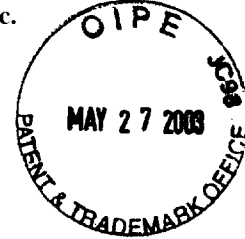

This Assignment may be executed in counterparts, each of which shall be deemed an original and both of which when taken together, constitute one and the same instrument.


