Motion to accept liabilities of LLC at a value of \$14,745.75 passed 6-0.

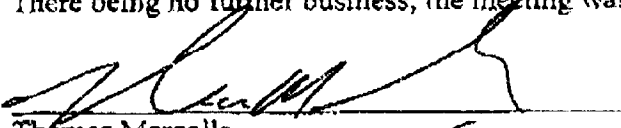

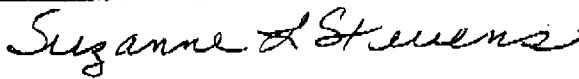
Motion to adjourn the Board of Managers Meeting passed 6-0.
