

ASSIGNMENT OF MARKS

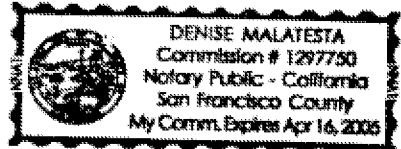
