(SECTION 185)

1. Name of amalgamated corporation:  
CHAMPLAIN INDUSTRIES LIMITED
  
2. The place in Canada where the registered office is to be situated:  
Regional Municipality of Peel,  
Province of Ontario.
  
3. The classes and any maximum number of shares that the Corporation is authorized to issue:  
An unlimited number of common shares.
  
4. Restrictions if any on share transfers:  
No share in the capital of the Corporation shall be transferred nor assigned without the approval of the directors certified by a resolution of the Board of Directors. Approval of such transfer or assignment of shares may be given as above, after the said transfer or assignment has been recorded in the books of the Corporation, in which case unless the said resolution otherwise provides, the said transfer or assignment shall be valid and shall have effect as at the date it has been recorded in the books of the Corporation.
  
5. Number (or minimum and maximum number) of directors:  
A minimum of 1 and a maximum of 7.
  
6. Restrictions if any on business the corporation may carry on:  
None.
  
7. Other provisions, if any:  
(a) The number of shareholders of the Corporation shall be limited to fifty (50), exclusive of present or

former employees of the Corporation or of a subsidiary of the Corporation, two (2) or one persons holding one (1) or more shares jointly being counted as a single shareholder.

- (b) Any distribution or securities to the public or invitation for the subscription or the distribution of an instrument or security by the Corporation is prohibited.
- (c) The directors of the Corporation may, when deemed expedient:
  - (i) borrow money upon the credit of the Corporation;
  - (ii) issue debentures or other securities of the Corporation, and pledge or sell the same for such sums and at such prices as may be deemed expedient;
  - (iii) mortgage, hypothecate, pledge or otherwise create a security interest in all or any moveable or personal, immoveable or real or other property of the Corporation, owned or subsequently acquired, to secure any obligation of the Corporation.
- (d) The Directors may, by resolution or by by-law, provide for the delegation of such powers by the Directors to such officers or directors of the Corporation to such extent and in such manner as may be set out in the resolution or by-law, as the case may be.
