NUNC PRO TUNC TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into as of this 6th day of February 2003, by and between CenterPoint Energy Houston Electric, L.L.C. (formerly known as Reliant Energy, Incorporated), a Texas limited liability company ("Assignor"), and Reliant Resources, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor owns the marks set forth on Schedule A attached hereto (collectively the "Marks"), and has established certain goodwill in such Marks, or, as applicable, Assignor has intended to use such Mark in commerce and has filed the application, identified by the corresponding application serial number, indicating its intention, but has not yet filed an allegation of use under §§ 1(c) or 1(d) of the Trademark Act, 15 U.S.C. § 1051 *et seq.*;

WHEREAS, Assignor is assigning the Marks as part of the entire business or portion thereof to which the Marks pertain and Assignee is a successor to such business or portion thereof, to which the Marks pertain, as required by 15 U.S.C. § 1060;

WHEREAS, Assignee wishes to acquire and Assignor wishes to assign all right, title and interest in and to the Marks, together with the goodwill symbolized by the Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign to Assignee and Assignee accepts *nunc pro tunc*, effective as of August 31, 2002, all right, title and interest in and to the Marks, the goodwill symbolized by the Marks, the registrations and applications thereof, and all rights of action accrued and to accrue under and by virtue thereof, including the right to sue and recover for past infringement.

Assignor agrees that it shall, without additional compensation, execute and deliver further instruments of conveyance, transfer and assignment as requested by Assignee, its successors, or assigns; reasonably cooperate and assist in providing information for making and completing regulatory and other filings; and take any and all other actions as Assignee, its successors, or assigns may reasonably require to effectively assign, convey, transfer, protect,

enforce, and exploit the Marks, their associated goodwill, and all rights therein to Assignee, its successors, or assigns.

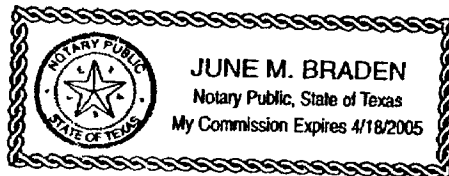

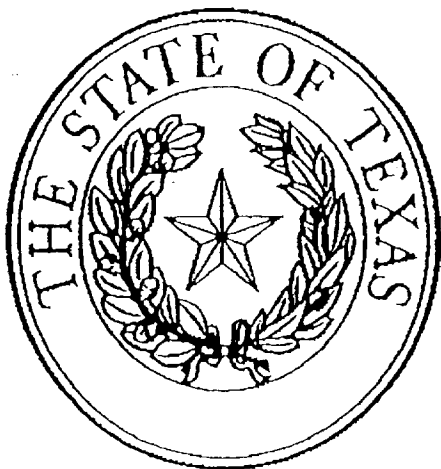

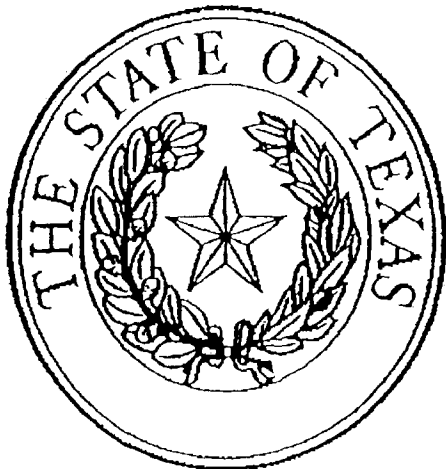
