ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (the "Assignment") is made by and between LYMPHEDEMA SERVICES, L.C., a Florida limited liability company with offices at 12651 West Sunrise Blvd., Sunrise, Florida, 33322 ("Assignor"), and KESSLER REHAB CENTERS, INC., a Delaware corporation with offices at 300 Executive Drive, Suite 275, West Orange, New Jersey 07052 ("Assignee").

WHEREAS, Assignor is the owner of the mark LERNER LYMPHEDEMA SERVICES ACADEMY, and other mark, logotype, and design incorporating or derived from the foregoing mark, including without limitation the mark shown in U.S. Reg. No. 2,420,292 (all of the foregoing, the "Mark"); and

WHEREAS, effective April 28, 2002, Assignee acquired from Assignor certain assets of Assignor's business and is desirous of acquiring the Mark and any registrations or applications for registration of the Mark, including U.S. Registration No. 2,420,292 (the "Registration"), and the goodwill of Assignor's business symbolized by the Mark, free and clear of all liens.

NOW, THEREFORE, effective April 28, 2002, for good and valuable consideration, receipt of which is hereby acknowledged, and intending to be legally bound, Assignor hereby sells, assigns and transfers to Assignee and its successors and assigns, *nunc pro tunc* as of April 28, 2002, its entire right, title and interest in and to (a) the Mark, together with the Registration and any other registrations and applications for registration of the Mark, (b) all income, royalties, damages and payments due as of or after the effective date of this Agreement arising from the Mark, and (c) all rights of action arising from the Mark, all claims for damages by reason of past, present and future infringement of the Mark and the right to sue and collect damages for such infringement, and (d) the goodwill of Assignor's business symbolized by the Mark.
