

ASSIGNMENT OF U.S. TRADEMARKS

WHEREAS, ABB Asea Brown Boveri Ltd., a corporation of ^{Switzerland}~~Sweden~~, having its principal place of business at Box 8131 CH-8050 Zurich, Switzerland (hereinafter "ASSIGNOR"), is the owner of the entire right, title and interest, including goodwill, in and to the trademarks set forth on Schedule A, attached; (hereinafter "MARKS"); and

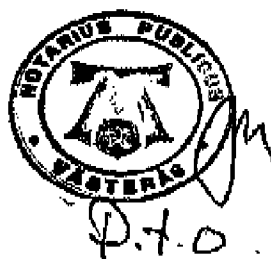
