

TERMINATION OF INTEREST IN TRADEMARKS

This TERMINATION OF INTEREST IN TRADEMARKS is executed as of August 28, 2003, by Bombardier Direct Corporation, a Delaware corporation (the "Secured Party"), with reference to that certain Note Purchase and Guaranty Agreement, dated as of March 30, 2001 (the "Note Purchase Agreement"), between Overton's, Inc. (the "Borrower"); N.W. Hunting, Inc., a now dissolved North Carolina corporation ("N.W. Hunting"); Decoy, Inc., a now dissolved North Carolina corporation ("Decoy"); H & D Acquisition Company, a now dissolved North Carolina corporation ("H&D"); V. Parker Overton; Michael V. Overton; Kristi O. Johnson; and the Secured Party.

Pursuant to the Note Purchase Agreement, each of Borrower, N.W. Hunting, Decoy, and H&D (collectively, the "Owners") executed and delivered to the Secured Party a Trademark Security Agreement, dated as of March 30, 2001, which was recorded with the United States Patent and Trademark Office on June 21, 2001, at Reel/Framc 2324/0120 (the "Agreement").

For good and valuable consideration, receipt of which is hereby acknowledged, the Secured Party hereby:

- (a) terminates the Agreement;
- (b) releases the liens and security interests granted to it in and on the trademark registrations referred to in the Agreement, including, without limitation, the registrations listed on Schedule 1 hereto (the "Property") and acknowledges, agrees and confirms that it has no right, title or interest in or to (or security interest in) the Property; and
- (c) to the extent the Secured Party shall be deemed to have any right, title or interest in the Property, retransfers and reassigns to Borrower all of such right, title and interest.

This Termination of Interest in Trademarks shall be governed by the laws of the State of New York and shall relate solely to the Agreement and shall in no way be construed as relating to any other trademark interest in the Property which the Secured Party may have.

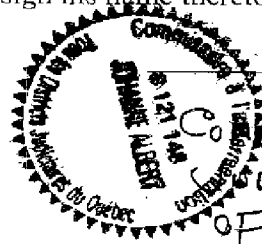
