THIS DEED OF ASSIGNMENT (the "Deed") is made the 7th day of January
2002

BETWEEN:

- (1) **COPLEY MOTION SYSTEMS LLC**, a corporation incorporated in the State of Delaware and whose place of business is Luckyn Lane, Pipp's Hill, Basildon, Essex, SS14 3BW ("CMS");
- (2) **LINEAR DRIVES LIMITED - IN ADMINISTRATIVE RECEIVERSHIP**, a company incorporated in England and Wales whose registered office is at Old Library Chambers, 21 Chipper Lane, Salisbury, Wiltshire, SP1 1BG ("Linear Drives") acting by one of its Administrative Receivers **JULIE ANNE HEGGARTY** and **MICHAEL FRANCIS STEVENSON** both of 21 Chipper Lane as aforesaid ("the Administrative Receivers");

WHEREAS:

Further to the Business Sale Agreement dated January 2002 (the "Business Sale Agreement"), Linear Drives wished to assign to CMS all its Rights in its Intellectual Property Assets (hereinafter defined).

THIS DEED WITNESSES:

1. In this Deed, the following words and expressions shall have the following meaning:
 - "Domain Names" means all those domain names registered in the name of Linear Drives as set out in Schedule 3 hereto;
 - "Intellectual Property Assets" shall have that meaning as set out in Clause 2 herein;
 - "Patents" means all those patent registrations held and patent applications made by Linear Drives as set out in Schedule 1 hereto;
 - "Rights" means all patents, design rights (registered and unregistered), trade marks (registered and unregistered), copyright, domain names, database rights and know-how including all applications therefore and all other similar or equivalent industrial intellectual or commercial rights or properly subsisting under the laws of each and

every jurisdiction throughout the world, whether registered or not and whether vested, contingent or future and all reversions, renewals, revivals and extensions of any of the foregoing, and all rights under licences, consents, orders, statutes or otherwise in relation to any of the foregoing; and

"Trade Marks" means all those trade marks registered in the name of Linear Drives as set out in Schedule 2 hereto and all goodwill attaching thereto.

2. Linear Drives hereby assigns to CMS all Rights, title and interest as it may have, in the Patents, Trade Marks and Domain Names (together herein after referred to as the "Intellectual Property Assets") together with all statutory and common law rights attaching thereto including the rights for the Assignee to sue for damages and other remedies in respect of any infringements or misuse of any of the Rights which may have occurred in the opinion of CMS prior to the date of this Deed and to retain any damages obtained as a result of any action.

3. Linear Drives hereby warrants and represent to the Assignee that:

- (a) it has the power and authority to enter into this Deed and does not require the consent of any third party to enter into it;
- (b) it has not assigned or agreed to assign any or all of its Rights in the Intellectual Property Assets to any person other than CMS or otherwise charged, mortgaged or encumbered the same;
- (c) it has not licensed any or all of the Rights in the Intellectual Property Assets;
- (d) as far as it is aware, there is no litigation or proceeding pending or threatened involving the Intellectual Property Assets or any circumstances likely to give rise to such proceeding;
- (e) as far as it is aware, the Intellectual Property Assets do not infringe or misappropriate the Rights of any third party.

4. Linear Drives hereby covenants with the Assignee that it shall, at the expense of CMS, execute all such documents and render such assistance as CMS may reasonably request from time to time for the purpose of perfecting CMS's title to the Rights in the Intellectual Property Assets including, without limitation, making applications to register CMS as the proprietor of these Rights but subject to the Assignee paying the reasonable expenses of Linear Drives (if any) in that regard.
5. This Deed and the Business Sale Agreement constitutes the entire agreement and understanding between the parties hereto with respect to its subject matter and replaces all previous agreements or understandings between the parties. In the event of any conflict the terms of the Business Sale Agreement shall prevail.
6. This Deed shall inure to the benefit of any successor in title, affiliate or parent of the Assignee.
7. ~~This Deed shall be governed by and construed in accordance with the laws of England and Wales and the parties hereto submit to the non-exclusive jurisdiction of the Courts of England and Wales.~~
