## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment"), dated as of May \_\_, 2002, is entered into between Lucasfilm Ltd., a California corporation ("Seller"), and Inlighten, Inc., a Delaware corporation ("Buyer"), and is made contemporaneously with the acquisition by Buyer of certain assets of Seller.

### RECITALS

A. Buyer and Seller have entered into an Asset Purchase Agreement dated as of May \_\_, 2002 (the "Asset Purchase Agreement") which provides, among other things, for the acquisition by Buyer of certain assets of Seller.

B. Seller desires to transfer and assign all of its right, title to, and interest in the Trademarks utilized exclusively in the operation of the Business and which constitute part of the Purchased Assets and are identified in Attachment 1 (the "Transferred Trademarks") to Buyer, and Buyer wishes to acquire the Transferred Trademarks.

C. Capitalized terms used herein shall have the meanings given them in the Asset Purchase Agreement, unless otherwise defined herein.

### AGREEMENT

NOW, THEREFORE, for the consideration specified in the Asset Purchase Agreement and other good and valuable consideration, receipt of which is hereby acknowledged, Seller does hereby grant, bargain, transfer, sell, assign, convey and deliver to Buyer all right, title to, and interest in the Transferred Trademarks. The right, title and interest is to be held and enjoyed by Buyer and Buyer's successors and assigns as fully and exclusively as it would have been held and enjoyed by Seller had this assignment not been made, including all rights of action and damages for past infringement, for the full term of the Transferred Trademarks, or of any renewal, reissue, prolongation or extension thereof.

Buyer hereby acknowledges that Seller is not making any representation or warranty with respect to the Transferred Trademarks being conveyed hereby except as specifically set forth in the Asset Purchase Agreement.

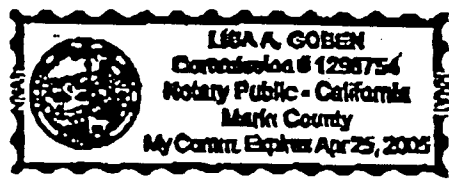
