

WHEREAS, this Amended and Restated Assignment of U.S. Trademarks shall replace that certain Assignment of U.S. Trademarks executed the 5th day of May, 2003, but never filed with the United States Patent and Trademark Office, pursuant to which Assignor inadvertently and by mistake (i) named Pristech, Inc., a former subsidiary and now dissolved Delaware corporation, assignee therein instead of Assignee and (ii) included the ProStretch Trademark among the trademarks in Schedule A, which trademark is not owned by Assignor the same having been previously assigned to a third party;

Now, therefore, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns to Assignee, and its successors in interest, without warranty from or recourse against Assignor, all right, title and interest in and to said marks, together with the goodwill of the business symbolized by said marks and registrations thereof, and including all common-law and other rights in said marks, all claims, demands and causes for action, both at law and in equity, that Assignor may have, or may hereinafter acquire, on account of any infringement of said marks prior to the date hereof, and does hereby empower Assignee,

and its successors in interest, to sue for and collect the same, to its and their own and absolute use.

IN WITNESS WHEREOF, the undersigned, being duly authorized and acting on behalf of Assignor, does hereby execute this assignment on the 28th day of July, 2003 to be effective on the 5th day of May, 2003.
