The undersigned officers of JACKSON HOLE SKI CORPORATION, a Wyoming corporation (the "Corporation"), do hereby certify as follows in connection with these Articles of Amendment:

1. The present name of the Corporation is JACKSON HOLE SKI CORPORATION. Such name is being changed hereby to JACKSON HOLE MOUNTAIN RESORT CORPORATION.

2. The Articles of Incorporation of the Corporation are hereby amended to change the name of the Corporation to JACKSON HOLE MOUNTAIN RESORT CORPORATION.

3. This Amendment was duly adopted by the directors and the shareholders of the Corporation at meetings duly held on October 21, 1998, with the name change to become effective as of June 1, 1999.

4. and 5. The only shares of capital stock of the Corporation issued or outstanding as of October 21, 1998 are 344,132 shares of common stock, no par value, which were duly voted in favor of adoption of such amendment.
