TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of November 7, 2003, is made by Wachovia Bank, National Association (formerly First Union National Bank), a national banking association, as Administrative Agent (the "Secured Party"), located at One First Union Center, TW-10, Charlotte, N.C. 28288-0608.

WHEREAS, New York Jets LLC, a Delaware limited liability company located at 50 West 57th Street, Second Floor, New York, New York 10019 (the "Grantor") granted a continuing security interest in and continuing lien upon certain personal property to the Secured Party, including without limitation a continuing security interest in and continuing lien upon certain trademarks ("Trademarks"); and


