MERCING BR PROCESSING, INC. INTO
M. A. HANNA COMPANY
(PURSUANT TO SECTION 253 OF THE GENERAL
CORPORATION LAW OF DELAWARE)**

M. A. Hanna Company, a Delaware corporation (the "Corporation"), does hereby certify:

FIRST: That the Corporation was incorporated on the 25th day of March, 1927 pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of each class of the capital stock of BR Processing, Inc., a corporation incorporated on the 13th day of June, 1957, pursuant to the Ohio Revised Code.

THIRD: That the Corporation, by the following resolutions of its Board of Directors, duly adopted on the 6th day of December, 1995, determined to merge into itself BR Processing, Inc. on the conditions set forth in such resolutions:

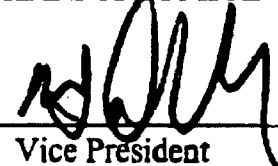

FURTHER RESOLVED: That the merger shall become effective on December 31, 1995.
