

and been dissolved. Tortum Oy changed its name on 27 March 1996 to

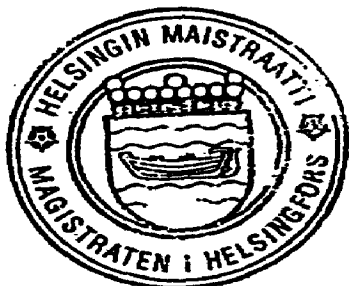


