BETWEEN**

“**ORTHOFIX S.r.l.**” having legal domicile in Milan, Piazzale Principessa Clotilde 8, and secondary domicile in Bussolengo (VR), Via delle Nazioni 9, with assets of EURO 1.560.000, fiscal code and number of registration in the Register of Enterprises of Milan 08976680150, in the person of its Chairman of the Board and Managing Director Mr. Vittorio Pietropoli, born in Verona on 24 November 1940 and domiciled for the office in Milan, Piazzale Principessa Clotilde 8, entrepreneur,

who is here attending as Legal Representative for the Company itself on the strength of the powers he is entitled to due to his double appointment,

Company hereinafter referred to as the “Assignor”

on one side

AND

“**ORTHOFIX INTERNATIONAL B.V.**”, established and existing pursuant to Dutch law having domicile in Amsterdam, Johannes Vermeerplein 11, 1071DV, enrolled in the Italian tax register with fiscal code number 97183500152, in the person of the Agent with limited authority Mr. Daniele Giglioli, born in Milan on 27 June 1933 and resident in Milan, via Gioberti 5, professional, and as such representative for the Company itself on the strength of the powers expressly received with authentic signed act on 18 December 2002 by Mr. Geoffrey Stc. Cornwall, Notary in Jersey (Great Britain), the original copy of which is attached herewith under letter “A”, which hereinafter will be referred to as the “Assignee”,

on the other side

jointly the Assignor and the Assignee the “Parties”,

WHEREAS

- a) The Assignor is the owner and full and exclusive proprietor of the trademark and patent rights (hereinafter referred to as the “Object”) filed and registered in a plurality of Countries (hereinafter referred to as the “Territory”) as specified in the lists which have been seen, approved and countersigned by the Parties herewith attached under numbers 1 to 39;
- b) It goes without saying that from now on the Orthofix Trademark and its derivations are excluded from the object and will continue to belong to the Assignor ;
- c) The Assignee is interested in buying the Object for the entire Territory;
- d) The effects of the present contract will come into force as of 1 January 2003.

IT IS HEREBY PROVIDED AS FOLLOWS:

The premises and annexes are an integral and substantial part of the present assignment deed (hereinafter referred to as the “Contract”) and they are therefore binding for both Parties.

The Assignor hereby sells, assigns and transfers to the Assignee, which accepts and buys, all the rights, titles and interests related to the Object for the whole Territory, without exceptions – save the

exclusion indicated in the previous premise sub b) - so that the Assignee becomes the sole owner and proprietor of the Object.

The Assignor ensures that said registrations are in full force and effectiveness, that it can freely dispose of them and that there is no pending litigation related to the ownership and/or validity thereof.

The Assignee will enjoy and benefit from all the rights derived from the Object and is therefore authorised to obtain the registration of the transfer at all the competent Authorities in the whole Territory.

The Assignor will not refuse to provide any reasonable assistance and, particularly, to undersign all documents submitted by the Assignee, in order to obtain said registrations.

The Assignor undertakes also, if it should appear that it owns, anywhere in the world, other rights related to the Object, whose existence was in good faith ignored, to assign and transfer said rights to the Assignee, which will owe nothing as a consequence of said further assignment.

The compensation for the present assignment is EURO 1.300.000, which will have to be paid, according to the conditions chosen by the Parties, by the Assignee Company to the Assignor Company between 1 January 2003 and 31 March 2003.

The present Contract is ruled by Italian law.

For any litigation arising between the parties about the interpretation, execution or resolution of the Contract, the Assignor's court will be exclusively competent.

The present deed is subject to I.V.A. (VAT), according to the D.P.R. 26.10.1972 no. 633 and so, for its registration, the application of the fix tax is compulsory.

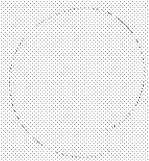
