





**PATENT AND TRADEMARK
ASSIGNMENT AND ASSUMPTION AGREEMENT**

This PATENT AND TRADEMARK ASSIGNMENT AND ASSUMPTION AGREEMENT ("Assignment") is made this 27th day of July, 1992 by and between PEABODY INTERNATIONAL CORPORATION, a Delaware corporation ("Assignor"), and GALION HOLDING COMPANY, a Michigan Corporation ("Assignee").

RECITALS:

A. Assignor, through its Galion Division, engages in the business of manufacturing and distributing garbage trucks, garbage compactors, dump truck bodies and similar equipment and machinery (the "Galion Business").

B. Assignor and Assignee have entered into a certain Agreement of Purchase and Sale, dated July 20, 1992 (the "Purchase Agreement"), pursuant to which Assignor has agreed to sell and Assignee has agreed to purchase substantially all of Assignor's assets used in the conduct of the Galion Business.

C. Pursuant to the Purchase Agreement, Assignor desires to assign all its right, title and interest in its patents, trademarks and other intangible, intellectual property used in connection with the Galion Business, and Assignee desires to assume all obligations of Assignor with respect thereto, all upon the terms and conditions as hereinafter set forth.

NOW, THEREFORE, the parties agree as follows:

1. Assignment of Patents, Trademarks and Licenses. Assignor hereby sells, assigns, transfers and sets over to Assignee all of Assignor's right, title and interest, whether now owned or existing or hereafter acquired or arising, in and to the following:

(a) patents, trademarks, trade names, service marks, service names, logos, copyrights, and all applications therefor, now or heretofore used by Assignor in the conduct of the Galion Business, or acquired by Assignor in connection with its acquisition of the Galion Business, including, without limitation, those listed on Exhibit A, plus (i) all renewals and reissues thereof, (ii) all income, royalties, damages and payments now and hereafter due and/or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages and payments for past or future infringements or dilutions thereof, (iii) the right to sue for past, present and future infringements and dilutions thereof, and (iv) all of Assignor's rights corresponding thereto throughout the world (all of the foregoing patents, trademarks, trade names, service marks, service names, logos, copyrights, and all applications therefor, including, without limitation, those listed on Exhibit A, together with the items described in clauses (i)-(iv) in this paragraph are collectively referred to as the "Patent and Trademark Rights");

(b) license and sublicense agreements with any other party in connection with the Patent and Trademark Rights or such other party's patents, trademarks, trade names, service marks, service names, logos, copyrights, and all applications therefor, whether Assignor is a licensor or licensee under any such license or sublicense agreement, including, but not limited to: (i) that certain Sublicense Agreement, dated January 29,

1991, by and between the Heil Co., a Wisconsin corporation, and Assignor; that certain Memorandum of Agreement, dated January 29, 1991, by and between the Heil Co., The Pullman Company and Assignor; and that certain Agreement dated February 8, 1991, by and between Sargent Industries, Inc., a Delaware corporation and Assignor (all of the foregoing being hereinafter referred to collectively as the "Patent and Trademark Licenses"); and

(c) the goodwill of the Assignor's business connected with and symbolized by the Patent and Trademark Rights and the Patent and Trademark Licenses.


2. Excluded Property. Notwithstanding anything to the contrary contained herein, Assignee acknowledges that Assignor shall have the absolute and exclusive proprietary right to all names, marks, tradenames, trademarks, service names and service marks incorporating "Peabody" and/or "Pullman" or any similar name, and to all symbols or logos incorporating "Peabody" and/or "Pullman" or any similar name, all right to which and the goodwill represented thereby and pertaining thereto are being retained by Assignor and are not included in the Patent and Trademark Rights assigned to Assignee hereby.

3. Assumption of Obligations by Assignee. Assignee hereby agrees to assume any obligations and liabilities of Assignor with respect to the Patent and Trademark Rights and the Patent and Trademark Licenses.

IN WITNESS WHEREOF, the parties hereto have duly executed this Assignment and Assumption Agreement as of the date first above written.


