

AFFIDAVIT OF OWNERSHIP PURSUANT TO 37 C.F.R. §3.73(b)

1. My name is Ralph A. Bianchi and I am a resident of Glen, New Hampshire.
2. At the time of the registration of the mark "DIP" on August 20, 1996, I was the President of JBF Scientific Co., Inc..
3. The assets of JBF Scientific Co., Inc., including the mark "DIP" were transferred to JBF Environmental Systems, Inc. in 1996 subsequent to the registration of the mark.
4. On July 22, 1998 I received the Assignment of a Promissory Note, Security Agreement and UCC-1 Financing Statement from Keybank, National Association (originally executed by JBF Environmental Systems, Inc., Ralph A. Bianchi and Philip M. Briggs in favor of Keybank, National Association), which included substantially all of the assets of JBF Environmental Systems, Inc. A copy of the Assignment is attached hereto as Exhibit A. The secured assets included the mark "DIP".
5. On October 5, 1998 I received a release bill of sale indicating the conveyance of substantially all of the assets of JBF Environmental Systems, Inc. from JBF Environmental Systems, Inc. to me. The conveyed assets included the mark "DIP". The assets were conveyed following a public sale pursuant to the terms of the assigned Promissory Note and Security Agreement. A copy of the Release Bill of Sale is attached hereto as Exhibit B.
6. As a result of these asset transfers, I am the current and sole owner of the mark "DIP" which was registered to JBF Scientific Co., Inc. on August 20, 1996.
