TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "*Assignment*"), dated November 21, 2003, is entered into by and between VeriSign, Inc., a Delaware Corporation ("*VeriSign*") having a principal place of business at 487 Middlefield Road, Building 2, Mountain View, CA 94043, Network Solutions, Inc., a Delaware corporation ("*NSI*") having a principal place of business at 487 Middlefield Road, Building 2, Mountain View, CA 94043, TLDs, a Delaware corporation ("*TLDs*") having a principal place of business at 487 Middlefield Road, Building 2, Mountain View, CA 94043 and Registrar L.L.C., a Delaware limited liability company ("*Assignee*") having a principal place of business at 2555 East Camelback Road, Suite 700, Phoenix, Arizona 85016.

RECITALS

A. VeriSign is the owner of the common law trade names, trademarks and service marks, registered trademarks and service marks, applications to register trademarks and service marks, intent-to-use applications and other registrations or applications related to trademarks and service marks listed on Schedule 1, attached hereto (the "*VeriSign Assigned Marks*").

B. NSI the owner of the common law trade names, trademarks and service marks, registered trademarks and service marks, applications to register trademarks and service marks, intent-to-use applications and other registrations or applications related to trademarks and service marks listed on Schedule 2, attached hereto (the "*NSI Assigned Marks*").

C. TLDs the owner of the common law trade names, trademarks and service marks, registered trademarks and service marks, applications to register trademarks and service marks, intent-to-use applications and other registrations or applications related to trademarks and service marks listed on Schedule 3, attached hereto (the "*TLDs Assigned Marks*"). The VeriSign Assigned Marks, the NSI Assigned Marks and the TLDs Assigned Marks are referred to collectively as the Assigned Marks.

C. Pursuant to the Purchase Agreement dated October 14, 2003, between VeriSign, NSI and TLDs along with other related or affiliated entities as sellers, Assignee and Pivotal NS, LLC, a Delaware limited liability company, as buyer, VeriSign, NSI and TLDs have agreed to assign their right, title and interest in the Assigned Trademarks to Assignee as a successor to and as part of the on-going business acquired by Assignee.

NOW, THEREFORE, in consideration of the foregoing and the mutual promises, covenants and conditions contained herein, the parties hereby agree as follows:

VeriSign, NSI and TLDs hereby assign unto Assignee all right, title and interest, including common law rights, in and to the Assigned Marks in the United States of America and in all countries and jurisdictions of the world, including the right to file for protection of the Assigned Marks throughout the world, together with the goodwill of the businesses symbolized by said Assigned Marks, and applications and registrations thereof, and that portion of the business which is ongoing and existing to which the Assigned Marks pertain. VeriSign, NSI and TLDs agree to perform, at Assignee's expense, all acts and to execute all documents necessary for Assignee to perfect its ownership in and to the Assigned Marks.

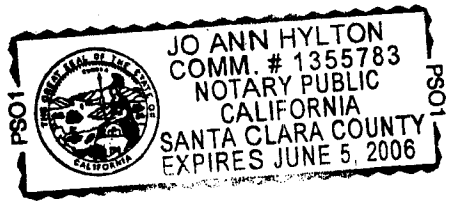
