**ASSIGNMENT OF PROMISSORY NOTE, SECURITY AGREEMENT
AND UCC-1 FINANCING STATEMENT**

This Agreement is made this 22nd day of ~~June~~^{July}, 1998 by and between KEYBANK, NATIONAL ASSOCIATION, formerly Key Bank of Maine, a national banking association with a place of business at Key Plaza, 23 Water Street, Bangor, Maine ("Assignor") and RALPH BIANCHI, an individual domiciled in the Town of Mount Desert, Maine ("Assignee").

RECITALS

Assignor is the holder of a certain Promissory Note ("Note") dated July 15, 1996 in the original principal amount of \$150,000.00 which Note was executed by JBF Environmental Systems, Inc., Philip M. Briggs and Ralph A. Bianchi. The original of said Note is attached to this Assignment. To secure said Note, JBF Environmental Systems, Inc. executed and delivered to Assignor a Security Agreement and UCC-1 Financing Statement, both of which are also dated July 15, 1996. Copies of the original Security Agreement and UCC-1 Financing Statement are also attached hereto as Exhibits B and C, respectively.

Subsequent to the execution of the Security Agreement, JBF Environmental Systems, Inc., with the consent of Ralph A. Bianchi, requested that Assignor release a portion of its collateral. Assignor acceded to that request and released a portion of its collateral.

AGREEMENT

NOW THEREFORE, for consideration paid, the receipt and adequacy of which is hereby acknowledged, Assignor does hereby give, bargain, sell and assign all of its right, title and interest in and to the following instruments to Assignee:

1. Promissory Note dated July 15, 1996 in the original principal amount of \$150,000.00, which Note is attached hereto as Exhibit A;
2. A Security Agreement dated July 15, 1996 with Key Bank of Maine as Secured Party and JBF Environmental Systems, Inc. as Debtor which is attached hereto as Exhibit B;
3. A UCC-1 Financing Statement dated July 15, 1996 with Key Bank of Maine as Secured Party and JBF Environmental Systems, Inc. as Debtor;
4. The Secured Party shall execute and deliver a UCC-3 Financing Statement to be filed with the Office of the Secretary of State of Maine in substantially the same form as is attached hereto as Exhibit D evidencing the assignment of its Security Interest to Assignee.
5. The parties hereto agree to take such other actions and execute such documents as may be reasonably requested by the other to complete and evidence the matters set forth herein.

This instrument shall be construed in accordance with the Laws of the State of Maine.
