

THIS ASSIGNMENT is made the 17th day of OCTOBER 2003

BETWEEN:-

- (1) **KPMG LLP**, a Limited Liability Partnership incorporated in England and Wales with registered number OC301540 and having its registered office at 8 Salisbury Square, London EC4Y 8BB (the "Assignor"); and
- (2) **KPMG INTERNATIONAL**, a Verein organised under the laws of Switzerland having its place of business at Burg Rijinderslaan 20, 1185 MC Amstelveen, The Netherlands (the "Assignee").

WHEREAS:-

- (A) The Assignor is the successor in business to the partnership of KPMG.
- (B) the Assignor is the applicant for (a) Community Trade Mark number 2368017 and (b) US Trade Mark number 76474567 for the trade mark GLOBAL SUSTAINABILITY SERVICES (the "Applications").
- (C) the Assignor wishes to assign its entire rights, title and interest in the Applications to the Assignee on the basis hereinafter set out:

NOW THIS AGREEMENT WITNESSES as follows:-

1. In consideration of the sum of One Pound Sterling (£1) (receipt and adequacy of which the Assignor hereby acknowledges), the Assignor as beneficial owner of the Applications and with full title guarantee hereby assigns and transfers unto the Assignee its entire rights, title and interest in the Applications and any registration resulting from either of them together with all rights of action, remedies, powers and benefits pertaining thereto to hold unto the Assignee, its successors and assigns absolutely.
2. The Assignor covenants that at the request and the cost of the Assignee it will at all times hereafter do all such acts and execute all such documents necessary or desirable both to secure the vesting in the Assignee of all rights assigned to the Assignee hereunder and to assist in resolution of any question concerning the same.
3. This Assignment shall be governed by and construed in accordance with English law and the parties hereto submit to the non-exclusive jurisdiction of the Courts of England and Wales.
4. **AND WHEREIN** it is understood and agreed that should the Assignee be dissolved, ownership of the Applications or any subsequent registration will be reassigned to the Assignor.
5. **IT IS HEREBY CERTIFIED** that the transaction hereby effected does not form part of a larger transaction in respect of which the amount or value or the aggregate amount or value of the consideration exceeds the sum of sixty thousand pounds sterling (£60,000).
