## ASSIGNMENT OF TRADEMARK

WHEREAS, Assignor now seeks to memorialize the assignment, transfer, and contribution of the Mark to Assignee,



1. Assignor shall duly execute and deliver or cause to be executed and delivered all instruments of sale, conveyance, transfer and assignment, and all notices, releases, acquittances and other documents that may be necessary more fully to grant, convey, transfer, assign and deliver to and vest in Assignee the Mark and other rights hereby granted, conveyed, transferred, assigned and delivered or intended so to be.


