## ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign and transfer unto Assignees undivided interests in the proportions set forth on Exhibit "B", all of the Properties (including the Rights, the Marks, registration applications and/or registrations, if any, and formulations relating thereto) together with the goodwill appurtenant to the Marks and the entire right, title, and interest in and to any and all claims and demands, Assignor may have either at law or in equity arising out of past, present or future infringement of the Marks.

Assignor, to the extent applicable, hereby authorizes and requests the United States Commissioner of Patents and Trademarks and other corresponding officials of other jurisdictions, as appropriate, to record this instrument to reflect Assignee as the owner of the Marks.






