**NUNC PRO TUNC TRADEMARK ASSIGNMENT**


This agreement, dated June 1, 2003 and effective as of December 9, 1998, is made between Scitex Corporation Ltd., an Israel corporation, whose principal place of business is Three Azrieli Center, Triangular Tower, 45<sup>th</sup> Fl., Tel Aviv 67023 (formerly of: Herzlia Industrial Park, P.O. Box 330, 3 Hamada Street, Herzlia B, Israel 46103 ) ("Assignor") and Scitex Digital Video, Inc., a Massachusetts corporation, whose principal place of business was 101 Galveston Road, Redwood City, California 94063, and its related entities ("Assignee").

WHEREAS, Assignor assigned the trademarks ANAMORPH, which is the subject of Federal Registration No. 2,021,187; AVK, which is the subject of Federal Registration No. 1,774,109; CLIPSTORE, which is the subject of Federal Registration No. 2,032,414; DVEOUSFX, which is the subject of Federal Registration No. 2,191,214; RETOUCH, which is the subject of Federal Registration No. 1,997,666; TIMEFRAME, which is the subject of Federal Registration No. 1,988,895; and ULTRAWARP, which is the subject of Federal Registration No. 2,127,499 (hereinafter the "Trademarks"), to Assignee on or about December 9, 1998;

WHEREAS, the Trademarks were to be further assigned and were in fact assigned by Assignee to Accom, Inc. on or about December 10, 1998; and

THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, effective December 9, 1998, Assignor sells, assigns, transfers, and conveys unto Assignee all right, title, and interest in and to the Trademarks and corresponding Registrations, together with the goodwill of the business pertaining thereto, and all claims for damages by reason of past infringements of the Trademarks, along with the right to sue for and collect such damages for the use and benefit of Assignee and its successors, assigns, and other legal representatives.
