RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of May 13, 2003 ("Effective Date") by and between The Hilsinger Company, L.P., a Delaware Limited Partnership ("Grantor"), and Banc of America Commercial Finance Corporation, as successor to NationsCredit Commercial Corporation and Nations Financial Capital Corporation, a Delaware Corporation ("Grantee").

WHEREAS, pursuant to the terms and conditions of those certain Trademark Security Agreements by and between Grantor and Grantee dated March 11, 1994 and June 24, 1999 (the "Trademark Security Agreements"), Grantor granted to Grantee a continuing security interest in and to certain defined Trademark Collateral, which include the Grantor's trademarks, as well as applications and registrations therefor, trademark licenses and products and proceeds of any of the foregoing, including the registrations set forth on Schedule A hereto (collectively, the "Trademarks") together with the goodwill associated therewith;

WHEREAS, Grantor and Grantee entered into the Trademark Security Agreements pursuant to the terms and conditions of that certain Security Agreement by and between Grantor and Grantee dated March 11, 1994, as amended (the "Security Agreement");

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office ("PTO") at Reel 1183/Frame 0019 and Reel 1951/Frame 0590 respectively;

AND WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreements and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Trademarks.

Grantee represents and warrants that: (i) it has the full power and authority to execute this Release; (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Trademarks; (iii) it has not recorded or otherwise evidenced its security interest with respect to any trademark, or registration of an application to register the foregoing, or any trade name or assumed name, other than those of the foregoing set forth on Schedules A and B (attached hereto), in any jurisdiction throughout the world; and (iv) Schedule C attached hereto sets forth a complete and correct list of all of the filings made by or on behalf of Grantee to record or otherwise evidence any security interest it has against the Trademarks in any jurisdiction throughout the world.

If and to the extent Grantee has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to Grantor.


Grantee shall take all further actions, and provide to Grantor and each of its successors, assigns or other legal representatives, all such cooperation and assistance (including,
