TRADEMARK ASSIGNMENT

The assignment is made and shall be subject to any unexpired license previously granted by ASSIGNOR, by an affiliated company of the ASSIGNOR, or by any predecessor in title of the ASSIGNOR, or any retained by any predecessor in title of the ASSIGNOR, under any of the Trademarks.
