TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT made as of November 7, 2003, by and among Trout and Zimmer Inc., a Delaware corporation with an address at 3727 West Magnolia Blvd., Suite 102, Burbank, California 91510 U.S.A. (the "Assignor") and Bombardier Inc., a Canadian corporation with an address at 1061 Parent Street, Saint Bruno, Quebec J3V 6P1 Canada (the "Assignee").

Assignor owns right, title and interest to the trademark 3D SAILING, and related goodwill, used by, or under license from, the Assignor in connection with the design, development, manufacture or distribution of boats and related parts and accessories. Assignor also owns United States Trademark Registration 2,725,184 for the trademark.

Assignor acquired the trademark 3D SAILING and the registration therefor, from Douglas W. Lord, an individual, with the intention of immediately reselling same to the Assignee. Assignor therefore now wishes to assign all its right, title and interest to the Trademark, the registration therefor, and all goodwill related thereto, to Assignee, and Assignee wishes to accept the assignment of same.

NOW, THEREFORE, for Eight Thousand Five Hundred United States Dollars (US\$ 8,500) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby assign to Assignee, its successors, assigns and legal representatives, all its right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark and any applications and/or registrations therefor in every jurisdiction throughout the world, including United States Trademark Registration No. 2,725,184 registered June 10, 2003, and the right (but not obligation) to assert the Trademark and to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past or future acts of infringement that have occurred or may occur.

AND, HEREBY, Assignor further covenants and agrees that it will, without further consideration, communicate with the Assignee, its successors and assigns, any facts known to it respecting the Trademark and will testify in any legal proceedings, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the Trademark in the Assignee, its successors or assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths and generally do everything possible to aid the Assignee, its successors and assigns, to obtain and enforce the assignments hereunder and proper protection for the Trademark in any jurisdiction, it being understood that any expense of the Assignor shall be borne by the Assignee, its successors, and assigns.

The Assignee shall have the obligation to register this assignment in the appropriate registries and shall bear all costs related thereto.

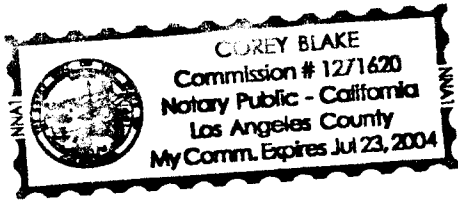
