AND THE ASSIGNOR HEREBY authorizes and requests the Commissioner of the United States Patent and Trademark Office, and any official of any country or countries foreign to the United States, whose duty is to issue, renew, and otherwise maintain trademark registrations or other evidence or forms of industrial and/or intellectual property protection on applications as aforesaid, to record this assignment and to issue the same to the ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

AND THE ASSIGNOR HEREBY covenants and agrees that all the properties conveyed herein are valid, subsisting and in full force and effect; that the ASSIGNOR has full right to convey the entire interests herein assigned; and that the ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith;

AND THE ASSIGNOR HEREBY covenants and agrees that the ASSIGNOR will execute, acknowledge, and deliver to ASSIGNEE, its successors, legal representatives and assigns, such other and further assignments, instruments, and documents as ASSIGNEE reasonably may request for the purpose of establishing, evidencing, registering, recording, enforcing, or defending its ownership of all rights, titles, and interests in and to the Properties. ASSIGNOR constitutes and appoints ASSIGNEE as ASSIGNOR's agent and attorney-in-fact, with full power of substitution, to execute and deliver such assignments, instruments, and documents as ASSIGNOR may fail or refuse to execute and deliver, this power and agency being coupled with an interest and being irrevocable.
