TRADEMARK ASSIGNMENT



Assignor hereby authorizes Assignee, and its successors and assigns, to the fullest extent permitted by applicable law, to file in its own name applications for trademark and copyright registration in the United States and in foreign countries in connection with the Mark, and to secure in its own name the registrations granted thereon. Assignor also hereby appoints Assignee as its agent to act in Assignor's name and on Assignor's behalf to take any action necessary to effect the transfer of any of the Mark to Assignee, or prosecute or otherwise enforce any claims, rights or benefits relating to the Mark. Assignee grants Assignor the non-exclusive, non-transferable right to use the Mark for a period of six (6) months from the date of this Assignment for the purposes of transitioning Assignor's business.

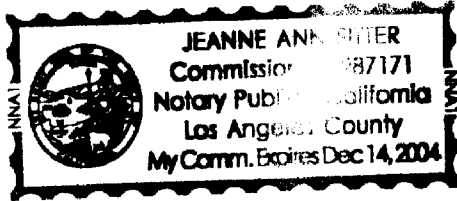


