ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
THE ORIGINAL OATMEAL BAKING COMPANY

Pursuant to the provisions of Section 23B.10 of the Revised Code of Washington, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is The Original Oatmeal Baking Company.
2. Article 1 of the Articles of Incorporation is amended in its entirety to read as follows:

"ARTICLE 1. NAME


"The name of the corporation is Integrated Bakery Resources, Inc."
