RELEASE OF SECURITY AGREEMENT

This RELEASE OF SECURITY AGREEMENT is made effective as of the 30th day of September, 2003, by PNC Bank National Association, as Collateral Agent for itself and the other lending institutions ("Collateral Agent") party to that certain Second Amended and Restated Credit Agreement, dated as of November 15, 2002, among the Collateral Agent, Key Corporate Capital Inc., U.S. Bank National Association, Axian Communications, Inc., Multimedia Integrated Systems, Inc., Geary Electric, Inc., Cable Express, Inc. ("Cable Express"), Charles Taylor Communications, Inc., Broadband Express, Inc., Express Tech Services, Inc and Midtown Express, Inc, that amended and restated that certain Amended and Restated Credit Agreement, dated as of August 8, 2001, that amended and restated that certain Credit Agreement, dated as of May 31, 2000.

WHEREAS, a certain Collateral Assignment of and Ratification of Security Interest in Intellectual Property Interest dated at or around September 1, 2000 ("Trademark Agreement") was entered into by and between Cable Express and Collateral Agent; and


WHEREAS, pursuant to the Trademark Agreement, Collateral Agent recorded a security interest in that certain trademark listed on Exhibit A attached hereto with the United States Patent and Trademark Office (the "Trademark").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent acknowledges that (a) the Trademark Agreement is hereby terminated and all security interests in the collateral assigned therein are released, including the security interest in and assignment of the Trademark; and that the same shall be null and void and have no further force and effect and (b) Cable Express or any other party designated by Cable Express is authorized to file any documents necessary to effectuate such termination and release.
