

## TRADEMARK ASSIGNMENT

WHEREAS, HOBBY HILL LIGHTNING, INC., an Illinois corporation ("ASSIGNOR") has adopted, uses and is using the mark "HOBBY HILL" registered in the United States Patent and Trademark Office as Registration No. 2,566,730 (the "Mark").

WHEREAS, T.J. HAGGERTY, INC., a Wisconsin corporation ("ASSIGNEE") desires to acquire the Mark and the registration thereof pursuant to the Asset Purchase Agreement dated as of the date of this Trademark Assignment between Assignor and Assignee;


NOW, THEREFORE, in consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which by ASSIGNOR and ASSIGNEE is hereby acknowledged, ASSIGNOR hereby sells, assigns, and transfers to ASSIGNEE all of its rights, title and interest in the Mark, together with all goodwill associated therewith.

Absent express authorization by ASSIGNEE, ASSIGNOR agrees to refrain from the use of the Mark in any way and for any purpose or to use in commerce any other mark in connection with the sale, offering for sale, distribution, or advertising of any goods or services when such use is likely to cause confusion, or to cause mistake, or to deceive any party as to the source of any goods and services offered by ASSIGNOR or as to the sponsorship of ASSIGNOR, its business, products, or services. The waiver by ASSIGNEE of a breach by ASSIGNOR of this section shall not operate or be construed as a waiver of any subsequent breach by ASSIGNOR. Any use of the Mark by ASSIGNOR, under the terms of this section or otherwise, shall inure to the benefit of ASSIGNEE.

This agreement shall be binding upon and shall inure to the benefit of the heirs, legal representatives, successors, and assigns of the parties hereto.
